This month marks the launch of TECC's first-ever membership drive. We are very excited about the growth this will bring to

the organization and the increase in watershed stewardship that will naturally occur in our region.

Without the support of members like you, The Escondido Creek Conservancy (TECC) would not be able to protect and preserve one of North County's real treasures. the Escondido Creek watershed. For those of you who

The threats to the watershed are many, and there is much to be done. Major developments in Escondido, Harmony Grove, Elfin Forest, and Rancho Santa Fe are being proposed.

I am pleased to report we have been remarkably successful since the Conservancy was founded in 1991. We are particularly proud that TECC has preserved more than 1,000 acres of open space in the watershed through direct purchase or by working in cooperation with the county of San Diego and local developers.

Designated open space, owned by TECC, the County, Olivenhain Municipal Water District (OMWD), and private developers now stretches from Del Dios Highway to the creek. Additional acreage contiguous to the creek is presently being

negotiated for acquisition by TECC.

Throughout Elfin Forest Recreational Reserve and downstream, you can observe the large restoration project taking place that will reestablish the native vegetation of chaparral, oaks, and sycamores that were destroyed by the taller non-native eucalyptus trees (Eucalyptus camaldulensis) and invasive giant reed (Arundo donax), which blocked the sunlight. With the donation of native trees from local nurseries arranged by TECC and the work of OMWD and hundreds of volunteers, this promises to be one of the most beautiful areas in all of San Diego County.

Thanks to your generosity, TECC, in collaboration with OMWD, has raised more than \$300.000 so far to construct an Interpretive Center at the Elfin Forest Recreational Reserve. This will serve to build a greater understanding and appreciation of this precious ecosystem.

In achieving our successes, TECC acknowledges the vital and important relationships it has formed with the Elfin Forest/Harmony Grove Town Council, the Endangered Habitats League, The Nature Conservancy, the Friends of Daley Ranch, the Olivenhain Municipal Water District. 
To the left, Randy Smith, Tom French, and Sandi Jacobson conduct chemical water sampling on the creek at Elfin Forest Recreational Reserve. The three volunteers are members of Golden State Flycasters (GSF), a fishing club dedicated to the preservation of fisheries and fly fishing. The three were part of a group of 20 volunteers who received training from San Diego Coastkeeper in the sampling protocols. TECC is indeed fortunate to benefit from GSF's adoption of Escondido Creek for their citizen monitoring work. Volunteers are needed! Contact the TECC office to learn how to participate.

To the right, several concerned citizens look over the site of the proposed Lennar Bridges Unit 7 development. Escondido Creek and the existing Bridges development are in the distance to the south of the project site. This project would construct about 30 custom homes on 80 acres in the heart of the core California gnatcatcher habitat, in the future MSCP-North (Multi-Species Conservation Plan). TECC, joined by the Endangered Habitats League and the Elfin Forest Harmony Grove Town Council among other groups, is opposing this project on several grounds, including placing the local gnatcatcher population in jeopardy. A final recommendation by the San Diego County Planning Commission on this project, originally scheduled for Jan. 26, has been delayed until after March 1.

## Summary of Projects and Issues in the Watershed

The Lennar Homes Bridges Units 6 and 7 development proposals are still pending before the County Planning Commission. The Unit 7 project would construct about 30 houses on 80 acres of prime coastal sage scrub - the preferred habitat for the California gnatcatcher.

Based on this fact and other concerns such as emergency access and community character, TECC continues to oppose the project and maintains regular communication with the proponents. Future hearings will be after March 1...

The Harmony Grove Village proposal for 750 homes on more than 400 acres currently occupied by egg ranches and dairy farms - was approved by the County County Board of Supervisors on Feb. 7. TECC continues to be opposed to the current project density and will address a variety of issues as the project continues to go before permitting agencies...

With the recent successful passage of Prop. 84. designating more than \$5 billion in funds for acquisition and restoration statewide, a number of regional efforts are currently underway to identify and prioritize projects.


TECC is participating in: the Integrated Regional Watershed Management Plan (IRWMP) process and the San Diego Conservation Resources Network's Land Acquisition Pipeline project (TECC's Executive Director serves on the SDCRN ExCom.). TECC's proposals in these ranking processes include a number of collaborative land acquisition projects in the watershed...

**TECC** recently learned of a proposal to build a 1,200-unit development on 500 acres on Mt. Whitney, just above Questhaven Retreat in Elfin Forest. The project, named University Heights, poses a significant threat to rural community character and open space systems...


TECC is an active participant in discussions revolving around Rancho Guejito and the owner's recent bid to file for annexation to the city of Escondido. This 20,000-plus-acre intact Mexican Rancho is a priceless open space jewel adjoining the upper headwaters of Escondido Creek....

**TECC** recently distributed 350 direct mail pieces to every home in Elfin Forest and Harmony Grove, with information concerning managing invasive plants and landscaping with natives. The mailing was made possible by a grant from the Elfin Forest Community Foundation...

The Interpretive Center Capital Campaign has reached the \$300,000 point, and a citizen design review advisory committee is being formed to review design proposals to be submitted in response to an RFP. Occupancy of the center is planned for mid-2009. We can't wait!

In January, the current managing partners of Rancho Guejito announced their intentions to annex this 20,000-plus-acre intact Mexican rancho to the city of San Diego. Located above the upper headwaters of Escondido Creek, the owners of this pristine open space jewel have up to now indicated their intention to keep the rancho intact as open space.
